Summary of duties

This role takes responsibility for the development, delivery, maintenance and evaluation of all teaching and learning programs (including short courses) within the Diploma and Certificate of Pharmacy Practice. In particular, this position provides leadership in the effective design and development of programs and ensures that subjects will meet the future and current learning needs of students and the industry.

The pharmacy course co-ordinator is responsible for the continuous improvement of the course, the quality of its teaching, and its interaction with the domestic and international community. It is the responsibility of the pharmacy course co-ordinator to ensure that the welfare of students and staff is adequately monitored and maintained.
