## SINU Council passes 2024 budget

n Tuesday, November 14th 2023, the Solomon Islands National University (SINU) Council approved the 2024 budget of \$240,342,783, showing an increase of \$10,583,782 from 2023.

The breakdown includes a \$182,345,383 recurrent budget and a significant government grant.

The council unanimously endorsed the 2024 budget based on recommendations from the Finance and Resources Committee.

During the recent meeting of the SINU Council, several crucial agendas were discussed and approved. The three key items on the agenda are outlined below:

### 1. Revised Physical Master Plan 2022-2032:

The Council resolved to adopt and approve the Revised Physical Master Plan 2022-2032 for immediate implementation. Additionally, there was a recommendation for the management to develop the University Academic Masterplan. In line with this, Director IPA, Darius Darlyn Ramo, was designated to coordinate the development of the Academic Master Plan in consultation with the Deans.

#### 2. SINU Academic Calendar 2024:

The Council resolved to adopt and approve the 2024 SINU Academic Calendar. As per the Council's recommendation, the approved Academic Calendar will be circulated to all staff and the National Sporting Council for the hiring of SINU facilities in 2024.

#### 3. Amendment to Study Leave Policy:

The Council made amendments to the Study Leave Policy. Additionally, the Council took the following decisions:

- To make note of the dates of the National General Election 2024 once declared and to implement necessary measures ensuring SINU Staff and Students have the liberty to exercise their democratic rights.
- To be attentive to the official release of the King's Birthday date and put in place any required measures accordingly.

These decisions reflect the commitment of the SINU Council to strategic planning, academic excellence, and the well-being of its staff and students.

The Council resolved to approve Policy amendment of the Study Benefit Policy of 2019 Section 1, 2 and 3 as follows: "That the Council notes the review of the current HR Policy with reference to the Study Leave Policy."

"That the Council approves the recommendation (as per the amended Study Policy) that during study leave period, the Staff member will be eligible to receive eighty percent of their basic salary."

"Noting that that this provision covers the basic salary only and excludes all other benefits that staff members are typically eligible for when they are not on study leave."

"That the Council approves to the duration of Study Leave, the maximum permissible period of study leaves with pay to be as follows: (a) 28 months (2 years) to obtain a Master's degree with or by research."

- "(b) 39 months (3 years & 3 months) to obtain a Doctoral degree."
- "(c) Where obtaining a Master's degree is a condition precedent to registering for a Doctoral degree, 45 months (3 years & 9 months) to obtain both a Master's degree and a Doctoral degree."
- "(d) A Staff who has already been granted study leave to obtain a Master's degree may be granted the balance period to obtain a Doctoral degree, ensuring that the total study leave granted to the Staff does not exceed the limit of 45 months (3 years & 9 months) in total study leave entitlement."

In accordance with the Council's recommendation, the Director of Human Resources is tasked with informing all staff members and disseminating the updated study leave policy.

# Proposed amendment on SINU remuneration and benefits policy deferred

The Joint Senate and Senior Management Committee had adjourned the motion to amend the Solomon Islands National University (SINU) Remuneration and Benefits Policy for early next year 2024.

The amendment of the SINU Remuneration and Benefits Policy was one of the four key agendas presented for deliberation during the Joint Senate and Senior Management Committee (SMC) meeting held on Wednesday, 14 November 2023.

Following thorough discussion, it was collectively decided by the Joint Senate and Senior Management Committee at the motion requires additional consultation before a conclusive decision can be reached on the matter. This reflects a commitment to careful consideration and inclusive decision-making processes to ensure that any amendments made align with the best interests and welfare of all stakeholders involved.

## SINU successfully hosts learning event for Provincial Premiers

The Solomon Islands National University (SINU) has successfully hosted provincial premiers and some provincial secretaries in a one-day 'Learning Event', demonstrating the institution's seriousness in strongly promoting its core values.

The Strengthening Competitiveness, Agriculture, Livelihood, and Environment – Natural Resource Management (SCALE-NRM) Project, funded by USAID, has achieved notable success in supporting the Malaita Provincial Government and its people. The project has developed measures to safeguard forest resources from unsustainable logging

practices, addressing a critical issue for the Solomon Islands.

The project has facilitated the creation of an ordinance called the Forest Business Licenses Ordinance (FBLO) which will empower the Malaita Provincial Government to regulate the use and protection of forests. This initiative not only contributes to the reduction of Green House Gas (GHG) emissions but is expected to also generate revenue for the province.

SINU Vice Chancellor Dr Transform Aqorau, expressed pleasure in providing a platform for provincial leaders to gain insights into the "remarkable achievement".

"We believe that understanding and potentially adopting similar measures could greatly enhance capacity of other provincial governments to safeguard their people and resources."

Historically, provincial governments have had limited capacity to influence logging activities, as permits and licensing predominantly fall under the purview of the Solomon Islands National Government.

The newly strengthened Forest Business License Ordinance (FBLO) developed by SCALE-NRM offers a transformative approach. It provides regulatory authority and administrative procedures for the transparent issuance of provincial logging business licenses and ensures compliance with the conditions defined in the FBLO.

Dr Aqorau further stated that the "self-funded business licensing scheme could set a precedent for reducing illegal logging, not only in the Solomon Islands but across the Pacific region".

"It represents a significant step towards enabling provincial governments and their communities to exert greater control over their forest resources."

"As the Vice Chancellor of SINU, I am continually committed to fostering an environment that champions innovative solutions to both

longstanding and emerging challenges."

SCALE-NRM Project Chief of Party Dr Morgan Wairiu expressed appreciation to SINU for recognizing the innovative initiative and providing a platform whereby other provinces can learn lessons and possibly develop for their provinces.

Dr Wairiu stated that the Strong support and commitment from the provincial Government to control logging and manage natural resources in Malaita has resulted in the successful development and passage of the ordinance.

Dr Wairiu stated that the FBLO will contribute to a drawdown of over 360,0000 tons of CO2 over a five-year period, which is the equivalent of taking 78,260 cars off the road for an entire year.

He added "because provinces cannot control logging without much needed revenue, this scheme, through fees and increase cost imposed to conduct logging operation will ensure enforcement and compliance. This is also consistent and complements the National Forest Policy, an effort to address the already unsustainable forestry practices".

Speaking during the opening of the one-day workshop at the Heritage Park Hotel on Wednesday 29 November, Malaita Deputy Premier Joe Heroau thanked SINU and SCALE-NRM for bringing the Premiers together on the very important event.

Premier Heroau said while logging played a pivotal role in the economic trajectory of the country, its benefits comes at a cost.

"The challenges posed by logging industry are multifaceted."

"Environmental degradation, deforestation, loss of biodiversity and social dislocation are just a few of the issues we grapple with, "he added.

"As stewards of our land, it is our responsibility to strike a balance between economic development and the preservation of our natural resources for future generation."

In the meantime, Guadalcanal Premier Francis Sade thanked SINU stating the learning event is an eye opener for Premiers where he said they are looking forward to take the initiative on-board.
