This Contractor Agreement Amendment (CCA) is made and entered in Honiara this of April 2024.

BETWEEN

Solomon Islands National University (hereinafter referred to as "the Contractor"), of P.O.BOX R113, Kukum Campus, Honiara, Solomon Islands. Represented by the Vice Chancellor Professor Transform Aqorau.

AND

The Ocean Foundation, on behalf of its Ocean Science Equity Initiative ("the Program"), (TOF and the Program hereinafter together referred to as "**TOF**") of 1320 19th Street, NW, Suite 500 Washington, DC 20036, USA. Represented by the President Mark J. Spalding.

Both are hereinafter referred to as the "Parties".

Now the Parties Agree to the following Amendment.

1. Purpose

To Amend the Principal Agreement signed between SINU and The Ocean Foundation on 8 June 2023.

2. Scope of the Agreement

The scope of the Principal Agreement remain the same except for Clause (B) Term of Agreement and Clause (C) (3) Payment Schedule.

3. The Amendment

Short Title and Commencement

1. This service agreement may be cited as the SINU And TOF Amendment Agreement 2024 and shall come into operation on such date the Parties sign this agreement.

2. Clause B Amended

Clause B of the Agreement is now amended in the following respect;

a. By noting the balance of the existing provision of term of Agreement in Clause B. The term of this Agreement shall be the period that Contractor provides Services to TOF from May 31, 2023 to March 31, 2026, or until such time as it is terminated in accordance with the provisions set forth in Section M of the Principal Agreement.

3. Clause (C) (3) Amended

Clause C (3) of the Agreement is now amended in the following respect;

b. By noting the balance of the existing provision of Remuneration and Payment Schedule. The Contractor was paid an upfront sum of US\$1,650 after the contract was signed and required tax and wire transfer detail forms were submitted. Following delivery of the GOA-ON in a box kit, the Contractor will be paid upon receipt of interim reports every six months until the end of the Agreement, with the final 12% to be paid after Contractor has submitted the final report. Contractor will be paid according to TOF's normal payment process on the 15th and last day of the month.
